

**Foxborough Regional Charter School**  
**2010-2011 STUDENT TRANSPORTATION FEES**

Foxborough Regional Charter School Transportation shall provide services as follows: fee based Regional school bus transportation and Regional Late Bus transportation services. The monthly fee for the 2010-2011 bus pass is \$80.00 per family. Families may use one registration form for all students in their home.

**REGIONAL BUS**

To obtain a seat on the Regional bus, a complete set of 2010-2011 registration forms, proof of residence and payment in full of the first month's fee must be received by **April 30<sup>th</sup>, 2010**. Seats are limited and assignments will be made on a **First Come, First Serve** basis. Bus route and stop assignments will be determined based on the legal residence of the student(s). A late fee of \$25.00 per family will be added for applications received after **April 30<sup>th</sup>, 2010**, late registrants are not guaranteed a seat on the bus and will be assigned based on availability. Incomplete registrations will be returned, registrations without the first month's fee included will be returned, and registrations received after **April 30<sup>th</sup>, 2010** without the late fee will be returned and will need to be resubmitted. Additionally, eligibility for 2010-2011 registration is contingent upon your Transportation fees being current. Past due accounts will **not** be eligible to register for future services. **A bus pass is required to board the Regional bus.**

The Transportation fees for Regional services are **payable in advance and non-refundable**. The full, first months fee shall be paid to the School prior to the transporting of any student under this policy. The fee is not pro-rated once the student begins riding the bus. There will be no refunds because of a decision to withdraw a student from the bus. The transportation budget requires this policy with no exceptions in this matter except for economic hardship.

**REGIONAL LATE BUSES**

Registered Regional bus riders may ride the Late Bus at no additional fee, to obtain a seat on the Regional Late Bus **only**, submit a complete set of 2010-2011 registration forms and payment in full of the first month's fee, forms must be received by **April 30<sup>th</sup>, 2010**. A Late Bus pass is required to board the Regional Late Bus, they are handed out daily and are **first come, first serve**.

**No cash can be accepted**, all payments should be made by check/money order payable to F.R.C.S. and sent to school with your child, the first months fee submitted with the Registration contract must be in the form of a money order or cashier's check **no personal checks** will be accepted for the deposit. **Fees for Late Payments & Insufficient Funds**

There will be a fee of \$25.00 for any check returned for insufficient funds. A late fee of \$25.00 per family will be added for registrations received after **April 30<sup>th</sup>, 2010**.

**Bus Passes**

Bus passes will only be issued to those who have registered as defined above. Bus passes will be available for pick up in late August, and will be required and checked by the bus drivers and bus monitors as the student's board the bus. All students will be required to carry a bus pass every day to access the service.

**Replacement bus passes may be purchased for a \$5.00 fee.**

## TRANSPORTATION FEE SCHEDULE

1. Applications may be obtained at the Main Office, financial or other personal circumstances are treated with complete confidentiality. The fee shall not be prorated for one way, or for less than full use. There will be no refunds because of a decision to withdraw a student from the bus. The transportation budget requires a policy with no exceptions in this matter except for economic hardship. Confidential requests for a waiver or reduction of the bus fee will be given consideration based on the Federal Government's Guidelines for the free and reduced lunch program offered in the Foxborough Regional Charter School. Requests must be made in writing and include documentation of family size, proof of income, i.e. copy of payroll stub or proof of unemployment and a copy of the family's 2009 federal income tax return. Parent/Guardian is responsible for Transportation fees until their application is approved. Transportation/Fee Waiver Applications are available upon request.

2. Regular Bus Service Fees: In accordance with the Foxborough Regional Charter School's "Student Transportation Fee Policy", the following fees are effective as of the date below and shall remain in effect until further revision:

3. Under Mass. General Laws, students who are eligible for free or reduced lunch are eligible for Fee Assistance/Waiver.
